Introduction to a Home Inspection

-  A home inspection is a non-invasive inspection. No invasive testing is possible. The inspection is observational and operational. We can only inspect what we can see at the time of the inspection. In general we do not move personal items within the home. We will attempt to note large areas that we are unable to inspect due to obstructions within the home.
-  An inspection is meant to represent a home at a particular point in time. The inspection does not offer any representation of the condition of the home in the future.
-  The inspection focuses on functionality and safety issues. It is NOT a residential building code inspection.
-  A home inspection is NOT meant to identify cosmetic issues.
-  Some minor issues may be missed. It is not possible to identify all minor issues throughout a home during the duration of a home inspection. We will identify as many as we can, but they will be found while searching for more major issues. In general, our goal is to find the \$1000 issues, not the \$100 issues. We are looking to find the issues that will influence your decision to purchase, not the minor issues that can be fixed easily.
-  The following systems will be visually inspected:
 - The structure – interior and exterior
 - The roof
 - The exterior facings
 - The mechanicals (furnace, A/C, water heater)
 - The plumbing
 - The electrical
 - The interior living areas
-  Appliances will be inspected and/or run through partial cycles, but only as a courtesy. No representation can be made as to their ability to continue to function.
-  Findings from the inspection will be presented in three ways:
 - Visually – we will show you what we find (if buyer is present at the inspection)
 - Verbally – we will explain what we find (if buyer is present at the inspection)
 - Written – you will be emailed a computer generated report specific to your property at the end of the inspection.
-  A home inspection is NOT a home warranty or a home insurance policy. A home inspection is meant to improve your odds of purchasing a healthy home, but is not a guarantee that the home you are purchasing will meet your expectations.
-  *If you are dissatisfied with your home inspection in any way, please call us right away. We will do whatever we can to address the issue. We want you to be happy.*
